# Erasmus+ courses offered by the Department of Business and Organizations Administration of University of Peloponnese

## **Erasmus + Mobility Program**

The European Erasmus + Program aims to enhance the quality and strength of higher education in Europe. Students can choose mobility for studies or internships at partner universities.

The Department of Business and Organizations Administration (BOA) of the University of Peloponnese organizes and develops the program, with the Department's International Relations Committee and the Department's ERASMUS Academic Coordinator, with the support of the ERASMUS Office of the University of Peloponnese.

The program allows students and faculty members to study abroad, while the Department hosts incoming students and staff from partner universities.

BOA to enhance the mobility of the students:

- Recognizes all the ECTS credits that the student receives at the partner University.
- Encourages the participation of students in the ERASMUS mobility program, by organizing presentations and meetings where among others Erasmus students of previous years participate and share their experiences.
- The Erasmus call and the relevant documents can be found on the website of the University (About University of the Peloponnese, Application Procedure, Application Form, Course Catalogues, Grading System) and on the e-class platform (and more specifically: IN INGLISH LANGUAGE).

# **Outcoming students**

The mobility of outgoing ERASMUS+ students is regulated by the mobility regulations of the University of Peloponnese and the ERASMUS + Program.

The specific criteria that students of BOA should satisfy to participate in the program, are the following:

- Candidates should have completed the first two semesters of their studies and have successfully passed 70% of the courses of previous years by the date of their application.
- The GPA should not be less than 6.5. In different cases, sufficient justification should be provided.
- Language proficiency: Candidates should have adequate knowledge of the language of instruction of the host institution according to the requirements provided. The additional knowledge of a foreign language and / or the

attendance of the free English language courses offered by the department are counted at the final evaluation. Candidates should submit the relevant language qualifications, as certified by recognized international certification bodies. Level B1 is considered as the minimum level of language proficiency.

• Personal interview: The motivation to participate in the mobility program is evaluated by conducting a personal interview with the Erasmus academic coordinator of the department.

Please note that during the interview process, candidates are informed that:

- Their application is binding and cannot be canceled unless there are serious reasons (with relevant justification).
- The student can withdraw the application, without any penalty, until the day of the personal interview. In case of withdrawal after the announcement of the results, the candidate will not have the right to participate in future actions of the Program.
- Accommodation and food in the host country are settled under the responsibility of the students.
- The scholarship does not cover all travel expenses, but only a part of them.

The results of the academic performance of students during the mobility will be evaluated based on the detailed transcript they will present after the end of their transfer (Transcript of Records).

Mobility is considered successful when the student has been examined in courses equivalent to half of the ECTS which are declared in the Learning Agreement for Studies. Otherwise, a refund of part or all the scholarship amounts may be reclaimed.

#### **Erasmus Placement**

The students of the Department can conduct an internship abroad through the Erasmus Placement program.

The specific criteria that students of the Department should satisfy to participate in the program, are the following:

- Candidates should have completed the first two semesters of their studies and have successfully passed 70% of the courses of previous years by the date of their application.
- The GPA should not be less than 6.5. In different cases, sufficient justification should be provided.
- Language proficiency: Candidates should have adequate knowledge of the language of instruction of the host institution according to the requirements provided. The additional knowledge of a foreign language and / or the attendance of the free English language courses offered by the department are counted at the final evaluation. Candidates should submit the relevant language
